

GO Transit 2025 OLG Ride Monday, Play Friday Lottery Offer

(the "Offer")

OFFICIAL OFFER TERMS ("TERMS")

1. OFFER DESCRIPTION: This Offer is jointly provided by Metrolinx and the Ontario Lottery & Gaming Corporation ("OLG") (collectively, the "Sponsors"). In this Offer, Eligible Participants who have not previously registered on OLG.ca are eligible to receive an OLG.ca lottery bonus ("Lottery Bonus" or "Offer Reward") of \$15.00 (CAD) by signing up to receive GO Transit marketing communications, making at least one (1) round trip on GO Transit on a qualifying Monday as further set out in these Terms, and making a minimum \$1 lottery purchase on OLG.ca. **The OLG Promotion Specific Terms set out additional requirements the lottery purchase requirement and limitations with respect to the redemption and use of the Lottery Bonus provided pursuant to this Offer. The OLG Promotion Specific Terms and are incorporated into and form part of these Terms. Any terms not otherwise defined in these Terms shall have the definition set out in the OLG Promotion Specific Terms. In the event of a conflict between these Terms and the OLG Promotion Specific Terms, the latter shall govern.**
2. OFFER TERM AND ELIGIBILITY: There are two periods associated with this Offer: June 10, 2025, at 12:00 a.m. to July 21, 2025 at 11:59 p.m. (the "Ride Requirement Period") and June 19, 2025, at 2:00 p.m. to August 8, 2025, at 11:59 p.m. (the "Lottery Bonus Redemption Period"). The Offer Period may be extended or terminated early at the discretion of the Sponsors without prior notice. To be eligible for the Offer, the participant must: (1) be at least 18 years of age; (2) be a resident of Ontario located in the province at the time of participation; and (3) have not previously been registered for a Player Account on olg.ca or any OLG legacy website ("Eligible Participant").
3. HOW TO PARTICIPATE IN THE OFFER:

To participate in the Offer, the Eligible Participant must,

(a) during the Ride Requirement Period:

- i. sign up to receive marketing communications from GO Transit and register your PRESTO card information at gotransit.com/olg2025,
- ii. make at least one (1) round trip on GO Transit and pay the fare with their physical PRESTO card or PRESTO card in a mobile wallet between 12:01am and 11:59pm **on a Monday** during the Ride Requirement Period ("Offer Requirements"). The PRESTO card used for payment must match the information submitted under Section 3(a)(i) of these TERMS. One (1) round trip is completed when you board the GO Transit from any GO station or stop and exit at any other GO station or stop twice on the same Monday. For the purposes of this Offer, GO Transit means any GO bus and GO train; and

(b) During the Lottery Bonus Redemption Period:

- i. Use the link sent by Metrolinx to the Eligible Participant to initiate a qualifying lottery purchase and sign up for an OLG.ca Lite Lottery Account in accordance with Section 5;
- ii. Complete the lottery purchase, spending at least one dollar (\$1 CAD) on any lottery product on OLG.ca; and
- iii. On the redemption landing page (described in Section 5), enter and redeem the single-use promotional code provided by Metrolinx. The single-use code must be redeemed before August 8, 2025 at 11:59 PM ET.

Only one (1) Offer per Eligible Participant may be claimed. This Offer is valid for new OLG.ca Player Accounts only.

4. OFFER REWARD DESCRIPTION: In this Offer, upon completing the requirements set out in Section 3, the Eligible Participant will receive a Lottery Bonus from OLG in the amount of \$15 (CAD) which can be redeemed on OLG.ca. The Lottery Bonus must be accepted as awarded. The Lottery Bonus can only be redeemed by the Eligible Participant and has no cash redemption value and is not valid if reproduced, transferred, assigned or sold. The Sponsors reserve the right at their sole discretion to substitute another reward for one of equal or greater monetary value if the Offer Reward described above cannot be provided for any reason. The Lottery Bonus described in this Offer can only be earned one (1) time.

Redemption and use of the Lottery Bonus on OLG.ca is subject to the OLG Promotion Specific Terms, [General Bonus Fund Terms](#), and [Player Agreement - Terms and Conditions of Use for OLG.ca](#).

5. HOW TO CLAIM THE OFFER REWARD: Once the Eligible Participant has fulfilled the Offer Requirements as described in Section 3 of the Terms, the Eligible Participant will be contacted by GO Transit on the next Friday during the Lottery Bonus Redemption Period through email ("Contact") and be provided with a link to create a player account on olg.ca and a unique, single-use promotional code. To receive the Lottery Bonus, the Eligible Participant must, in accordance with Section 3 b, initiate a qualifying lottery purchase, sign up for a Lite Lottery Account on OLG.ca account using the URL provided in the Contact, complete the lottery purchase of not less than one dollar (\$1.00 CAD) on OLG.ca. After completing the purchase, the Eligible Participant will be directed to a promotion code redemption page where they must enter and redeem the single-use promotional code provided in the Contact to receive the Lottery Bonus. No correspondence will be entered into by Metrolinx except with the participant as set out in Section 5 above. If any provision of these Terms is declared invalid or unenforceable, such provision shall be deemed modified to the extent necessary and possible to render it valid and enforceable. In any event, the unenforceability or invalidity of any provision shall not affect any other provision of these Terms.

Metrolinx and OLG reserve the right in its sole discretion to disqualify, from this Offer and any future Offer or other promotion conducted by Metrolinx and OLG, any individual that it finds or believes to be tampering with the registration process or operation of the Offer, to be acting in

violation of these Terms, or in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person.
