


Groundwater Monitoring and Drilling near Galloway Road

Scheduled to resume: February 23 to March 6, 2026

Project Overview

GO service is expanding to serve you better - with more frequent service, more stations, cleaner technology, and more connections. Across the entire network, our goal is to deliver over 10,000 train trips a week - so you won't need a schedule because you know the next train will be coming soon. GO Expansion will transform the GO rail network from a commuter service into an all-day, rapid rail system.

What is happening?

As part of investigative work for the GO Expansion project, we will be conducting groundwater monitoring and drilling on Galloway Road to assess groundwater conditions. Borehole drilling will be carried out to support groundwater monitoring activities. There will be a temporary fenced parking site for the drill rig in the centre of Chantrey Court. These works are routine and intended for environmental assessment only. Due diligence and investigative work will support future track and infrastructure updates.

HOURS OF WORK

- Work is rescheduled to take place on February 23 to March 6, 2026, during daytime hours, from 8 a.m. to 6 p.m. There will be 4 days of overnight work for Pump testing. All work will take place within the areas shown on the map.

WHAT TO EXPECT

- Residents can expect some noise, visible presence of crews and large vehicles, and temporary traffic and lane adjustments.
- Staff will take reasonable precautions to minimize disturbances to residents, including but not limited to the following:
 - Reduced idling of non-essential equipment.
 - The work area will be safely secured.
 - White noise backup alarms on vehicles and machinery as required.
- Work will take place outside of the rail corridor.
- Work may be rescheduled due to inclement weather or unforeseen circumstances.
- We apologize for any inconvenience and ask for your patience as we complete this critical work.

DESCRIPTION OF WORK

- As part of investigative work, borehole drilling activities will be carried out to install temporary monitoring wells.
- These installations are temporary, short-term, and intended solely for groundwater assessment and environmental planning.
- Use of a drill rig and/or hydrovac truck will be required to complete this work.

PEDESTRIAN, TRAFFIC AND TRANSIT DETAILS

- Temporary lane adjustments will be in effect on Galloway Road.
- Traffic control personnel will direct vehicles around work zones on Galloway Road between Dunera Avenue and Chantrey Court.
- Traffic will be maintained in each direction.
- Work areas will be delineated with signage.
- Please exercise caution near active work sites.
