#### 1 Introduction

Metrolinx, an agency of the Province of Ontario, is working to transform the way the region moves by building a fast, convenient and integrated transit network. Part of this plan is to bring more frequent and reliable transit service, known as Durham-Scarborough Bus Rapid Transit (DS BRT), along the Highway 2 and Ellesmere Road corridor (**Exhibit 1**).



**Exhibit 1: Study Area Map** 

The Durham-Scarborough BRT project was identified as a priority development project in Metrolinx's 2041 Regional Transportation Plan and is an important component of the 2041 Frequent Rapid Transit Network. Metrolinx is working with Durham Region, Durham Region Transit (DRT), City of Toronto and the Toronto Transit Commission on the next stages of the project, which includes a Preliminary Design Business Case (PDBC) and a Transit Project Assessment Process (TPAP).

The TPAP is a streamlined Environmental Assessment (EA) process that is specific to transit projects under Ontario Regulation 231/08. The TPAP includes a pre-planning phase followed by a formal 120-day consultation period and a 30-day public review period. To engage with interested persons along this diverse corridor, four rounds of Public Information Centres (PICs) are planned. Three rounds occurred prior to the start of TPAP, and one round is planned during TPAP.

Public Information Centre #1 was held in Oshawa, Whitby, Ajax, and Pickering in June 2019, and in Toronto in September 2019. Public Information Centre #2 was held in Oshawa, Whitby, Ajax, Pickering, and Toronto in November 2019.

Public Information Centre #3 was hosted virtually between November 16, 2020, and January 10, 2021.

This report summarizes Public Information Centre #4, which was hosted virtually between October 14 and November 11, 2021. The purpose of Public Information Centre #4 was to present and seek feedback on the preliminary design, potential impacts, and proposed mitigation measures.

#### 2 Event Information

Due to COVID-19 restrictions and precautions, consultation was conducted virtually on the project website (<a href="www.metrolinxengage.com/dsbrt">www.metrolinxengage.com/dsbrt</a>). Information on the website included display boards, design drawings, renderings and an online comment form to solicit public feedback. The project's online interactive map was also updated as part of Public Information Centre #4 (<a href="www.dsbrtmap.ca">www.dsbrtmap.ca</a>).

The Public Information Centre #4 was open from October 14 through November 11, 2021 to allow for public engagement and to receive additional feedback. Three live events were held on-line on October 21, 26 and 28, 2021 for synchronous interaction with the project team. Materials were also posted to the project website for the public to view outside of these events.

#### 3 Notification of Public Information Centre #4

A number of methods were used to notify the public, stakeholders, and Indigenous Nations of the Public Information Centre #4, including mailouts (addressed mail and unaddressed mail), emails, newspapers advertisements, and online notices. The formal Notice of Public Information Centre #4 is provided in **Appendix A**. A full list of the organizations that were notified of Public Information Centre #4 is provided in **Appendix B**. The appendix also includes copies of the notifications.

Details of the notifications for the Public Information Centre #4 events are as follows:

- The Notice of Public Information Centre #4 was mailed to 1,281 property owners in Scarborough and 1,331 property owners in Durham Region within 30 metres of the study area on October 10, 2021 as addressed mail (Appendix A);
- Postcards with project information including notice of the Public Information Centre #4 were sent as unaddressed mail to all mailboxes within 500 m either side of the corridor on October 12, 2021;

- The Notice of Public Information Centre #4 was emailed to 10 Indigenous Nations on October 14, 2021 (Appendix B);
- The Notice of Public Information Centre #4 was advertised in six local newspapers in two consecutive publications (**Appendix C**):
  - Scarborough Mirror October 14 and 21, 2021;
  - Ajax-Pickering News Advertiser October 14 and 21, 2021;
  - Whitby This Week October 14 and 21, 2021;
  - Oshawa This Week October 14 and 21, 2021;
  - Clarington This Week October 14 and 21, 2021; and
  - L'Express Toronto October 15 and 22, 2021.
- Public Information Centre #4 information was available on the project website (<a href="https://www.metrolinxengage.com/en/engagement-initiatives/durham-scarborough-bus-rapid-transit">https://www.metrolinxengage.com/en/engagement-initiatives/durham-scarborough-bus-rapid-transit</a>) as of October 19, 2021;
- Stakeholders that attended the Stakeholder Advisory Group, Technical Advisory Group, and Municipal Technical Advisory Group meetings held in October were informed of the upcoming Public Information Centre #4 events. The meetings were held on the following dates:
  - Durham Stakeholder Advisory Group: October 19, 2021;
  - Toronto Stakeholder Advisory Group: October 18, 2021;
  - Technical Advisory Group: October 27, 2021;
  - Durham Municipal Technical Advisory Group: October 12 and 13, 2021;
  - Toronto Municipal Technical Advisory Group: October 13, 2021.

The members of the Stakeholder Advisory Group, Technical Advisory Group, and Municipal Technical Advisory Group were also notified about the commencement of Transit Project Assessment Process (TPAP) and invited to attend the Public Information Centre #4 by email on October 14, 2021. Correspondence detailing these notifications is provided in **Appendix B**.

• Information on the Public Information Centre #4 events was tweeted by Metrolinx (@Metrolinx) on October 18, 2021, which was also shared by Town of Whitby (October 21,2021) and City of Oshawa (October 20, 25 and 27, 2021).

#### 4 Information Presented

The purpose of Public Information Centre #4 was to present and seek input on the technically preferred preliminary design and results of the technical studies, including potential impacts and proposed mitigation measures. The virtual Public Information Centre #4 included the following components:

- Live event & recordings;
- Webpages and display boards;
- Design drawings and renderings; and
- Interactive map.
- Public Information Centre #4 DS BRT Video

Each component is further detailed below. The recordings of the live event, webpages and display boards, design drawings and renderings were available on the project website (<a href="www.metrolinxengage.com/dsbrt">www.metrolinxengage.com/dsbrt</a>). The interactive map was hosted on a separate website (<a href="www.dsbrtmap.ca">www.dsbrtmap.ca</a>), but links were provided from the project website. Individuals were also able to request hardcopies of the Public Information Centre #4 materials by emailing <a href="mailto:dsbrt@metrolinx.com">dsbrt@metrolinx.com</a>.

Project information, including virtual display boards, was organized across different webpages based on different topics. From the main landing page (<a href="https://www.metrolinxengage.com/en/engagement-initiatives/durham-scarborough-bus-rapid-transit">https://www.metrolinxengage.com/en/engagement-initiatives/durham-scarborough-bus-rapid-transit</a>), users were able to navigate through different topics at their own pace and according to their own interests. #### Ask a Question

(https://www.metrolinxengage.com/en/content/durham-scarborough-bus-rapid-transit-faq-ask-question#comment-form): This webpage allowed participants to submit public comments or ask questions about the Public Information Centre #4 material. All comments were time and date stamped and publicly available. Metrolinx provided a timely response to all comments received. The public had the option to upvote or downvote the comments and responses, with "like" or "dislike" functions common to social platforms, to further enhance public feedback.

Information on the technically preferred design was available in the same format for each webpage. Participants could attend the live meetings during Public Information Centre #4 event and could also watch the recordings of past meetings as well. There was also an opportunity for participants to review the preliminary designs and roll plans at their own pace by viewing display boards of the design drawings. Renderings were included on the webpage to illustrate how the corridor would look if the technically preferred preliminary design was implemented. The webpage also included an interactive map illustrating the proposed changes to traffic lanes along the corridor. Finally, a comment form corresponding to the preliminary design was available for the public to provide feedback. Comments are summarized in Section 7.


#### **Interactive Map**

The technically preferred preliminary design was uploaded to the project's online interactive map (<a href="https://www.dsbrtmap.ca/">https://www.dsbrtmap.ca/</a>). The interactive map interface is demonstrated in **Exhibit 2**. The map allowed members of the public to view the design in detail and toggle between map and satellite view for additional context. Once zoomed in, viewers were able to see the location of the following elements: BRT lanes, stop platforms, concrete medians, cycling facilities and sidewalks. An example of these elements is included **Exhibit 3**.

The map also included renderings, existing traffic signals, community services, and existing transit stop locations. The public was able to provide feedback on the design by dropping a pin on a location of interest. Feedback received through the interactive map is summarized in Section 9.

#### 5 Participation

Participants were encouraged to ask questions, submit feedback, and share ideas with the project team. Input was received through multiple channels, including:

- Comment forms;
- Ask a Question webpage;
- Interactive map;
- Emails to DSBRT@metrolinx.com;
- Telephone calls; and
- Community meetings.

In addition to these channels, the public was invited to sign-up for the project mailing list and Durham and Toronto East e-newsletters, request hardcopies of Public Information Centre #4 materials, or provide feedback to the project team through the 'Neighbours & Engagement tab' webpage on the project website. Public input is further discussed in the subsequent sections.

#### 6 Engagement Statistics

Unlike at a traditional in-person Public Information Centre #4 event, sign-ins cannot be collected for virtual events. Instead, visitor and view counts were used to help assess the success of the public consultation event and rate of participation.

A post-engagement report was prepared to compile data on the rates of online participation during the Public Information Centre #4 and is included in **Appendix E**. The report documents all activities on the Public Information Centre #4 website (<a href="www.metrolinxengage.com/dsbrt">www.metrolinxengage.com/dsbrt</a>). The report measures public participation through three key performance indicators: page visits, active engagement, and input and includes website traffic, page views, questionnaire participation, and comments received on the "Ask a Question" platform.

A summary of key engagement statistics is provided below. The statistics represent participation between October 14, 2021, and November 11, 2021:

**Public Information Centre #4 Website:** 2,490 users visited the project website during Public Information Centre #4. The website amassed 6,899 unique pageviews and 8,838 total views.

Online Surveys: 69 surveys were submitted.

**Ask a Question Comments:** 11 questions were submitted by members of the public. The questions and responses received a total of 88 upvotes and downvotes.

**Interactive Map**: The map attracted 2,678 unique visitors. 11 comments were submitted by 5 individuals.

**Preliminary Design Pages:** Design drawings received a total of 1,152 views:

Toronto Preliminary Design: 335 views

Pickering Preliminary Design: 249 views

Ajax Preliminary Design: 183 views

Whitby Preliminary Design: 249 views

Oshawa Preliminary Design: 136 views

#### 7 Comment Form Results

Online surveys were located on the preliminary design pages for each of the five municipalities: Toronto, Pickering, Ajax, Whitby and Oshawa. The public was encouraged to complete the survey to provide feedback to the project team.

The surveys were available from October 14, 2021, to November 11, 2021. A total of 69 online surveys were submitted. A summary of responses is included in **Exhibit 4**. A full record of responses received is included in **Appendix F**.

- Dedicated centre lanes will improve traffic situation.
- Do not agree with new design plan.

## Are there design refinements you'd like us to consider during detail design?

#### **Toronto & West Turn Around**

- Protected intersections.
- Complete street fully realized, with lots of space for people to cycle, walk, and roll.
- Extend the dedicated bikeway east on Kingston Road across the Rouge River.
- Include secure bicycle parking and Bike Share stations at all the transit stops.
- Integration of the active transportation corridor with other trails and bike routes.

#### **Pickering**

- Better protection for cyclists at intersections.
- Connections to other cycling lanes with regional cycling plans.
- Refined bus shelter rendering and information showing material, colour, and shape.
- More accessibility to transit hubs like GO.
- Raised continuous sidewalks, safe bicycle stand/rack near bus platform and traffic calming measures throughout the streets.

#### **Ajax**

#### 8 Ask a Question Responses

Participants were encouraged to submit feedback, ask questions, or share their ideas to the project team by participating in the 'Ask a Question' message board. Users were required to register to be able to participate.

In total, 11 comments were posted to the virtual message board during the duration of the Public Information Centre #4. All comments were time and date stamped and received responses from Metrolinx. A record of the comments posted to the message board is included in **Appendix G**. The main themes of the comments are summarized below:

- Traffic impacts;
- Left turn lanes;
- In-person venues consideration for PIC event;
- Alternate route for BRT instead of Ellesmere between Port Union Rd and Morningside Avenue;
- Safe access for people from driveways during construction;
- Use of dedicated transit lanes by other transit agencies and emergency vehicles;
- Accessibility for pedestrians (with mobility devices or strollers at signalled intersections);
- Mitigation measures for the businesses that are impacted during construction; and
- Local and regional transit integration.

#### 9 Interactive Map Responses

The technically preferred preliminary design was uploaded to the project's online interactive map. The map allowed members of the public to view the design in detail and provide feedback by dropping a pin on a location of interest.

A total of 11 comments were received from 5 individuals. The comments, along with the responses from Metrolinx, are included in **Appendix H**. The main themes of the comments are summarized below:

- Prohibition of left turns;
- Support for safe cycle parking near bus stops;
- Concern for pedestrian safety especially seniors and children;
- Impacts to business deliveries/loading;
- Concern with safety of sidewalk on bridges; and
- Concern with additional lanes at intersections.

#### 10 Email Correspondence

Members of the public were able to provide input by emailing the project team at <a href="mailto:dsbrt@metrolinx.com">dsbrt@metrolinx.com</a>. During the Public Information Centre #4 comment period from October 14, 2021, to November 11, 2021, a total of 50 emails were received. Most feedback received through email was related to the following themes:

- Concern related to usage of Emergency Vehicles in Pickering Village;
- Concerns related to loss of parking spots;
- Concerns related to traffic at Mary Street, Whitby;
- Concerns related to access restrictions and prohibition of left turns;
- Concerns related to alignment in Oshawa;
- Concerns related to alignment in downtown Whitby;
- Concerns related to ending the DS BRT route at Simcoe Street in Oshawa;

#### 11 Community Meetings

Three community meetings and engagement sessions were held during the Public Information Centre #4 comment period. The meetings were hosted to help further understand the community's concerns related to the technically preferred preliminary design and project timelines in Scarborough and Pickering Village in Ajax. During these meetings and engagement sessions, the Durham Community Engagement Team presented information on the DS BRT's technically preferred preliminary design and timelines. This allowed members of the public to ask questions and receive responses from the project team and other panel members. Details are included in the following sections.

## 11.1 Durham Community Pop Up Trent University Oshawa Campus

Durham Community Engagement Team hosted a pop-up event on November 3, 2021, from 11:00 am - 2:00 pm at Trent University, Oshawa Campus. The purpose of this event was to discuss how DS BRT will benefit Trent University students and faculty members; DS BRT project timelines and what fares will look like.

To promote the Public Information Centre #4, Durham Community Engagement team handed out postcards and answered questions from students and faculty members. The team engaged with 14 members of the University and had some meaningful conversations about Metrolinx projects in the Durham region, including Bowmanville Expansion and DS BRT.

#### 11.2 Woburn Community Engagement

Durham Community Engagement Team hosted an in-person session on November 8, 2021, from 2:30 - 4:30 pm at 1200 Markham Road, Scarborough.

In response to the concerns from Councillor Paul Ainslie and MPP Mitzie Hunter, the team met with stakeholders in the Woburn community. The purpose of the meeting was to provide an update on the BRT project; discuss the proposed design along Ellesmere Road; need for centre median; and concerns related to vehicles not being able to turn left into some businesses. This engagement provided an additional opportunity to hear from the community and strategize on best practices for community engagement as the project moves forward.

#### 11.3 DS BRT Pop up Engagement in Pickering Village

Durham Community Engagement Team hosted a pop-up event on November 2, 2021, from 11:00 - 3:00 pm in Pickering Village, near the intersection of Kingston Road and Church Street, Ajax. The purpose of the event was to discuss the purpose and planning of the DS BRT project, listen to residents' concerns related to design and safety considering the technically preferred preliminary design plans.

To promote the Public Information Centre #4, the Durham Community Engagement team handed out information postcards. The team engaged with 12 community members and had some meaningful conversations with local residents. The event was attended by Regional Councillor Marilyn Crawford.

#### 12 Key Findings

The feedback received through the Public Information Centre #4 demonstrated that the public had the most interest and concern related to the proposed design where the DS BRT is located within Scarborough, downtown Whitby and Ajax.

In all the above-mentioned locations, the public recognized that the corridor is constrained and had varying opinions on elements that should be prioritized. Traffic congestion, environmental impacts and proposed lane configurations were significant concerns in both Whitby and Ajax. In Scarborough, people were concerned with congestion issues and prohibition of left turn due to dedicated transit lanes with raised curbs at the centre.

While most of the feedback on the design for Downtown Whitby was critical, the public commented favourably on the plan to widen sidewalks, improve the streetscape, provide Multi-Use Path and improve accessibility.

Similarly, the design for Ajax was met with some criticism. However, the public acknowledged and supported the effort to maintain cultural heritage resources and the provision of dedicated transit lanes.

The public also showed an interest in local transit and cycling route integration. Some feedback identified important connections to intersecting transit routes and cycling facilities.

Below is a summary of the key concerns and opportunities that were identified.

Concerns about:

- Traffic infiltration;
- Access restrictions;
- Business impacts along Ellesmere Road and in Downtown Whitby;

Safety for all modes of travellers;

- Connection to other cycling lanes; and
- Environmental Impacts.

#### Opportunities to:

- Improve reliability and comfort of transit service;

- Implement mitigation measures to avoid huge environmental impacts during construction.

#### 13 Summary

Due to COVID-19, Public Information Centre #4 was conducted virtually. Despite the new format, the event was successful at engaging the public. With 2,490 visitors to the project website during Public Information Centre #4, the number of participants were less than previous consultation events held for DS BRT project. The reduction in participation rates can likely be attributed to the fact that Public Information Centre #4 was open for nearly four weeks as compared to eight weeks for Public Information Centre #3.

Another benefit of the online format was that the project information was provided in a variety of formats. For example, the public could choose to review the design on the interactive map; review the design drawings; or watch the recordings of PIC4 event.

Members of the public generally attended the Public Information Centre #4 to learn more about the project and provide feedback or voice concerns regarding the technically preferred preliminary design. Most feedback was received on the design in Downtown Whitby and Ajax. Little feedback was received on the technical studies, including the potential impacts and mitigation measures.

With a total of 50 emails and 69 survey responses received during the comment period, most of the feedback was received through comment forms to the project team. The public also submitted feedback through the interactive map and "Ask a Question" page.

The Project Team will continue to seek opportunities to obtain feedback throughout the Transit Project Assessment Period. Environmental Project Report will be developed to document the different technical studies conducted and the consultation with public, technical agencies, Indigenous Nations, and other stakeholders and will be made available for 30-day public review period.







As previously communicated on May 30, 2019, Metrolinx, a regional transportation agency, is overseeing the proposed Durham-Scarborough Bus Rapid Transit Project. The Durham-Scarborough Bus Rapid Transit Project proposes approximately 36 kilometres of dedicated transit infrastructure, connecting Oshawa, Whitby, Ajax, Pickering and Scarborough. This project builds on the existing PULSE service and will provide more dedicated transit infrastructure along Highway 2 and Ellesmere Road to connect from Downtown Oshawa to Scarborough Centre. This will include dedicated bus lanes, road expansion and modifications, and bus shelters/platforms and infrastructure to support the new bus rapid transit.

Metrolinx is working with Durham Region, Durham Region Transit, City of Toronto and the Toronto Transit Commission with the planning and design of this bus rapid transit project. An Initial Business Case (IBC) was completed in Spring 2018 to define the corridor and identify initial project costs, benefits and direction. The Stage 1 background study determined 76 previously registered archaeological sites are located within one kilometre of the Study Area. A total of 11 sites are within 50 metres of the study area. One of the sites within 50 metres (AlGs-449) retains Cultural Heritage Value or Interest and requires further assessment. Five cemeteries are located within or directly adjacent to the study area.

A property inspection determined that parts of the study area exhibit archaeological potential and will require Stage 2 assessment by test pit survey at 5 m intervals prior to any proposed construction activities. In addition, three cemeteries require a Stage 3 Cemetery Investigation (St. George's Anglican Church Cemetery in Ajax, Mount Lawn Cemetery in Whitby, and Union Cemetery in Oshawa).

As Metrolinx continues to undertake environmental due diligence for this project, additional archaeological assessment will be completed during detail design. Metrolinx acknowledges that Huron-Wendat Nation should be aware of and engaged regarding any future archaeology studies, and especially the discovery and preservation of Indigenous artifacts and sacred burial grounds. Metrolinx will keep Huron-Wendat Nation informed about any future needed studies and identify opportunities for participation.







The province's police watchdog is investigating after a 41-year-old man died after interacting with a police negotiator at a Scarborough home on Saturday evening.

The Special Investigations Unit (SIU) said police responded to an unknown trouble call at a home on Castledene Crescent near Huntingwood Drive and Pharmacy Avenue at 7:27 p.m.

"A police negotiator made contact with the man. During the negotiation, the man sustained a

The civilian agency investigates whenever there is a serious injury, death or sexual assault allegation involving police.

There were no injuries reported.

Toronto police said officers found shell casings, shattered glass and damaged vehicles "as a result of gunfire."

The investigation is ongoing. Police didn't release a description of the shooter or shooters.

A man has died after being hit by the driver of a vehicle earlier this month in the Scarborough Junction

The collision happened on Friday, Oct. 1, around 10:30 p.m. near Eglinton and Midland avenues.

Toronto police, in an Oct. 4 news release, said a 46-year-old man was crossing from the northwest corner to the southwest corner of Midland at Eglinton.

At the same time, a driver travelling northbound on Midland turned westbound onto Eglinton and stuck the pedestrian, police said.

The man sustained lifethreatening injuries and was rushed to hospital. On Saturday, Oct. 2, he died of his injuries.



# AJAX MEN CHARGED WITH ATTEMPTED MURDER IN OSHAWA SHOOTING

An investigation into a daytime shooting in Oshawa that left a man seriously injured has led to the arrests of two suspects, police say.

Two Ajax men face charges including attempted murder relating to the incident, which occurred just before noon Sept. 9 at the intersection of Ritson Road and Bond Street, Durham police said. A suspect fled on foot after firing shots into a car, police said at the time.

A 25-year-old victim was taken to hospital with serious injuries.

In an update police said suspects were arrested Oct. 1 in Barrie and Oct. 6 in Woodbridge.

Dana Williams, 34, and Jermaine Weekes, 36, both

# GO ANNOUNCES EXPANDED REFUND PROGRAM FOR SERVICE DELAYS

Acknowledging that delays are inevitable, the company that operates GO Transit has taken measures to keep riders happy by expanding the list of types of delays that are eligible for a refund through its Service Guarantee program.

The new measures took effect Oct. 7 and mean that GO is expanding its service guarantee to include all regularly scheduled trips delayed by 15 minutes or more - regardless if the delay is caused by GO Tran-

In the past, the guarantee only applied to delays specifically caused by GO, like signal or switch problems, door issues, and mechanical failures. Now it also covers incidents such as police investigations, onboard emergencies, and pedestrian incidents.

GO Transit operates on a special schedule in severe weather, will be ineligible for reimbursement.

Special flat-fare tickets, including the Weekend Pass and Weekend Day Pass for unlimited travel, are not eligible for Service Guarantee refunds.







# CATHOLIC BOARD TO **GATHER STUDENT** IDENTITY DATA IN SPRING

## DCDSB IS PLANNING TO CONDUCT ITS FIRST STUDENT **CENSUS IN APRIL** 2022

Durham's Catholic school board will be conducting its first student census this spring.

The census for students in Grades 6 to 12 is scheduled for April 25 to 29, 2022 and will collect identity data such as race, religion, and sexual orientation.

"We need this data," says Margaret Brimpong, senior manager of equity, anti-racism and engagement for the Durham Catholic District School Board.

'This data is so vital in moving us forward so that teachers are better able to respond to students in the classroom.'

The census will be voluntary and confidential with the option for students to skip questions.

Students in Grade 8 and below will either have a parent complete the census for them, or complete it together with a parent.

The province requires school boards to collect student identity data as part of efforts to address racism and inequity in schools.

Ontario school boards have until the beginning of 2023 "to ensure that they are aligned with provincewide data collection ef-

Many boards have already taken this step.



Durham Catholic District School Board graphic The Durham Catholic District School Board will be conducting its first student census in April 2022. The census will gather data on things like student race, religion and sexual orientation.

The Durham District School Board did its first student census in April 2019 and saw 46 per cent of students in Grades 7 to 12 respond as well as 30 per cent of parents of students in kindergarten to Grade 6.

The DDSB is using the data to do valuable analysis — including highlighting an achievement gap for Black students.

"This is a very exciting opportunity to really get to know our student body in detail, to find out what their needs are and address those directly," said trustee Monique Forster at Durham Catholic's Sept. 27 board meeting.

The province requires the census to include mandatory questions on Indigenous identity, race, ethnic origin, religion, first language, gender identity, sexual orientation, disability, status in Canada and socioeconomic status.

"There's not a lot of wiggle room in terms of what we can do with this survey, but we do have two or three questions that we can develop in addition," says Brimpong.

The DCDSB conducted its first staff census in 2019.

A followup report highlighted the fact that nonwhite people are under-represented at the board, compared with Durham as a whole.

For example, it says 12 per cent of the board's permanent, full-time employees are "racialized," compared with 27 per cent of the population in Durham.

A DCDSB student census webpage with more information will go live on Oct. 29.




# **DURHAM REGION MAN,** 57, KILLED IN KAWARTHA LAKES CRASH: OPP





En me garant, j'ai remarqué des personnages sur un vieux silo, indiquant la South Liberty Trail, dont je n'avais jamais entendu parler. Je ne voyais pourtant pas de sentier aux alentours...

### Liberty Village: un café d'abord

Arvo est le deuxième café indépendant, d'abord installé à La Distillerie, a avoir ouvert ses portes dans Liberty Village. Balzac's l'avait fait bien avant

Ils ne sont pas loin l'un de l'autre, mais bien différents. Alors que Balzac's (43 avenue Hanna) loge dans un bel édifice historique, Arvo (80 avenue Atlantic) a opté pour un grand espace lumineux dans un nouvel édifice.

Pour la première fois depuis la pandémie, je me suis assise DANS un café, profitant de la connexion Internet d'Arvo pour faire mes recherches sur l'intrigante South Liberty Trail. Par un heureux hasard, Arvo se trouve justement sur la rue comprenant le premier silo du sentier.

Avant de commencer la balade, jetez un coup d'oeil sur le collage de bois coloré qui orne l'allée juste au nord du café. Puis, descendez vers le sud jusqu'au bout de l'avenue Atlantic.

### **South Liberty Trail**

En 2017, un projet d'art public (le premier de son genre à Toronto), géré par Mural Routes, a choisi d'utiliser comme canevas quatre grands silos et deux trémies (sorte de grands entonnoirs de métal) se trouvant non loin des voix ferrées, dans la partie sud du quartier. La South Liberty Trail était

Ne vous attendez pas à un sentier de nature urbaine! On est ici dans un ancien quartier industriel.

Bien que son point de départ soit

la station de trains GO Exhibition, les oeuvres se trouvent entre l'avenue Atlantic et la rue Dufferin. Présentement, des constructions au pied d'Atlantic bloquent d'ailleurs l'accès à la station GO se trouvant vers l'est.

# Des oiseaux et une perspective

Au bout de l'avenue Atlantic, on admire le premier silo, situé aux abords de la maison mère de Joe Fresh (2 Atlantic Ave). Il faut faire le tour de l'oeuvre de 8 mètres de hauteur de l'artiste Young Jarus pour voir le bel oiseau qui se cache de l'autre côté.

En traversant le terrain vers l'ouest, on croise un tout petit bout de verdure. On passe à côté de la grande outarde sur le silo rouge de birdO aka Jerry

Puis on longe de vieux édifices bardés de graffiti. Regardez bien! On y fait des trouvailles, dont une vaste murale toute en perspective.

Observez bien l'édifice de brique rouge avec ses arches, qui figure au centre. Vous le verrez un peu plus loin au coin de l'avenue Mowat Ave et de la rue Liberty.

# Un oeil et des personnages

Le très beau silo surplombant la rue Fraser est du muraliste Alex Bacon. Cherchez le chat!

Puis remontez la rue Fraser pour découvrir l'oeil géant de Bacon sur la trémie de l'édifice The Bakery (2 rue Fraser). Explorez derrière la trémie pour voir le grand nid aux oeufs bleus.

Contournez l'édifice en allant vers le nord sur Fraser et traversez le premier espace de stationnement pour rejoindre l'avenue Mowat, où vous tournez à gauche pour voir les personnages de Troy Lovegates sur un grand silo blanc.

Traversez la rue et marchez vers l'ouest dans le premier espace de stationnement à votre gauche. Il appartient à SoftChoice (20 Avenue Mowat) et donne accès à la rue Dufferin, où nous attend une autre oeuvre de Troy sur la trémie.

#### Les bancs en métal découpé de **Liberty Village**

J'ai terminé la balade en remontant Dufferin vers le nord puis en trouvant vers l'est sur la rue Liberty. Sur le chemin, on remarque de beaux supports à vélo et des bancs publics en métal découpé. Le quartier en a reçu 14 en 2019.

Mon banc préféré se trouve sur l'avenue Pardee, trois rues plus à l'est. J'ai d'abord acheté une délectable brioche à la cardamome à la boulangerie BrodFlour (8 avenue Pardee), et m'y suis installée en compagnie des petits danseurs jaunes de Thelia Shelton sur le banc juste en face.

Ce circuit fait au total 2 kilomètres. Vous pouvez ajouter 2 km à votre balade en suivant la section suivante.

# **Exploration dans Liberty Village**

Au sud de la rue Liberty, vous pouvez traverser le grand terrain de stationnement entre Jefferson et Hanna pour atteindre la seule allée couverte que je connaisse dans Toronto. En la traversant, j'ai découvert avec joie qu'un de mes petits restaurants préférés vient

d'y ouvrir le comptoir de commandes à emporter Aloette Liberty Village.

Au bout, continuez votre chemin sur la rue E. Liberty pour voir quelques très belles pièces d'art public. Les roches en équilibre au 89 E. Liberty. Les pigeons rouges de Nathan Mabry au 49 E. Liberty, à l'est de la rue Pirandello.

Prenez ensuite Western Battery Road vers la gauche, juste avant l'avenue Strachan, puis empruntez les raccourcis passant dans les petits parcs jusqu'à Pirandello. Tournez à droite pour rejoindre Western Battery Road, puis à gauche.

# Pont piétonnier

Dans le coude de la rue, vous remarquerez un édifice aux fenêtres décorées d'une grande étoile. Il s'agit de la cage d'escalier et d'ascenseur du pont piétonnier qui p-sse au dessus des voies ferrées pour nous mener à la rue Douro. Quand on utilise l'ascenseur, on peut pleinement admirer les étoiles.

J'ai conclu la balade en me dirigeant vers l'ouest jusqu'à l'avenue Hanna, où un passage piétonnier longe le magasin West Elm (qui semble ouvert seulement pour les pick ups) et descend jusqu'à la rue King West.

Le viaduc à cet endroit date de 1888 (un des plus vieux à Toronto).




