#### **Overview**

- Construction noise was raised as an issue
- Other areas of concern were construction schedule, noise wall and ambiguity of language in the health and safety plan.
- MPP Tabuns spoke about the long term and short-term noise barriers being installed prior to work commencing.
- This was his understanding from the language in the H&S plan; however, Paul Collins clarified that this has never been the plan and throughout all previous meetings it was repeatedly stated that a longer-term solution would follow.
- In March, the long-term barrier was presented as an option. There were also concerns raised about timeline and design of long-term noise barrier.
- Residents have been using mobile devices to measure noise levels next to the work site

- The Parent Council asked for feedback and commitments to using the school's baseline indoor/outdoor noise monitoring data; Metrolinx team will need to review the document first before this can be committed to

### **Next steps**

- 1) Actions to stop worker smoking at the Bell work site.
- 2) Review and provide response to TDSB reports on baseline noise levels and a review of the Pape/Langley Health & Safety Plan.
- 3) July-Sept install school yard noise wall; after foundation in place, wall to be install within a couple of weeks.
- 4) Metrolinx to expedite process to execute agreement with TDSB for the installation of the noise wall.
- 5) Share Metrolinx HSE audit of the Pape/Langley Health & Safety Plan with CLC.
- 6) Share Enbridge work plan with the CLC well in advance of the work starting.
- 7) MX will stop work when school notifies MX that the work is disrupting learning.
- 8) MX available to meet on site with community members to review issues and mitigations related to Bell work site.
- 9) Updates to be made to H&S plan to clarify ambiguous language around noise wall and afterhours security
