
# Tree Removals and Demolition at Sammon Avenue and Pape Avenue

Expected start date: As early as March 11, 2024

Expected duration: One (1) month

Hours of work: Monday - Friday, 7:00 a.m. to 4:00 p.m.



## What is happening?

 To accommodate construction activities for the Ontario Line, crews will remove trees, landscaping, and vegetation on the properties outlined in the map above. In addition, the buildings on the properties will be abated and demolished. These buildings are on Metrolinx-owned properties.

- Starting as early as Monday, March 11, 2024, crews will begin the removing the trees, vegetation, and landscaping on the southeast corner of Pape Ave. and Sammon Ave., as well as in the front and rear yards of the properties at 887 and 885 Pape Ave.
- Crews will also begin the abatement and demolition of the buildings on the properties at 891, 887, and 885 Pape Ave.
- The buildings will be prepared prior to demolition with the removal of interior details.
- Metrolinx's Vegetation Guideline specifies how many trees need to be planted when any tree is removed, ranging from 1 to 50 new trees based on the size and location of the tree being removed. This guideline is used across our network to ensure more trees are planted than removed as we carry out the largest transit expansion in the history of the region.
- All work will take place Monday to Friday between 7:00 a.m. to 4:00 p.m. for approximately one (1) month.

#### What to expect

- Work will begin with clearing and removing 7 trees within the work area.
- All required permits have been obtained for the tree removals.
- Environmental experts will be on site to ensure tree removal is carried out in accordance with regulatory requirements. People near the sites may hear noise caused by chainsaws and woodchippers.
- During demolition, noise from construction equipment including excavators, bobcats, and dump trucks can be expected.
- Short-term traffic interruptions can be expected while trucks and equipment enter and exit work zones; traffic control personnel will be present to direct vehicles and pedestrians.
- Construction equipment and materials will be secured within the work zones.
- Signage and safety barriers will be in place to delineate work zones.
- This work may be delayed due to inclement weather and/or unforeseen circumstances.
