
Monitoring device installations: Queen Street East

Expected start date: As early as April 29, 2024

Duration: Up to six months

Hours of work: Weekdays (Monday-Friday), 9:00 a.m. to 4:00 p.m.

What is happening?

- Construction crews will be installing monitoring devices in the areas shown in yellow on the map above .
- The devices are required to monitor any ground displacement, potentially related to construction activities.
- Temporary lane and sidewalk closures are required for crews to safely carry out their work.
- Crews will complete different segments of work, moving within the various locations identified
 on the map. There will be intermittent closures of traffic lanes and sidewalks around active work
 zones.
- For investigative works, drilling is necessary to test and visualize the utilities and ground conditions under the street for future construction of the Ontario Line subway tunnels and Moss Park Station.

What to expect

- The work is scheduled to begin as early as April 29, 2024, and anticipated to be completed within six months.
- Work will take place during the weekdays, (Monday-Friday), between 9:00 a.m. to 4:00 p.m.
- Area residents and businesses can expect to hear noise from work equipment, specifically hydrovac trucks and saw cutting tools as required. Crews will take measures to minimize noise impacts wherever possible.
- All closures for work are temporary and intermittent; areas will only be closed while crews are surveying the specific areas. The areas will be returned to public use upon completion of the monitoring device installation.

Queen Street East intermittent partial closures (as noted in the map):

EASTBOUND:

- Eastbound curb lane between Sherbourne Street and Jarvis Street.
- Signage will be posted advising of the lane restrictions.

WESTBOUND:

- Westbound curb lane just east of Sherbourne Street to east of Jarvis Street.
- Signage will be posted advising of the lane restrictions.

Note: Access may resume prior to 4:00 p.m. if works are completed ahead of schedule.

- Two-way traffic will be maintained at all times.
- Access to area commercial units will be maintained.
- Barriers will be in place to separate motorists and pedestrians from active work zones.
- Transit services will be maintained at all times.
- After each work shift, each area will be securely covered and marked for safety until workers
 return or the work is complete. The areas will be returned to public use upon completion of
 the monitoring device installation.
- All the necessary construction permits have been obtained.
- Work may be postponed or rescheduled due to unforeseen circumstances.
