OVERVIEW:

On May 2, 2024, Metrolinx in collaboration with OTG, conducted a Community Liaison Committee (CLC) meeting to inform residents about the progress to date at the future King-Bathurst Station. This is a monthly CLC meeting to be held about ongoing construction progress at this specific station.

The meeting began with a land acknowledgement and an introduction to the Ontario Line by Bradley Naismith from Metrolinx. Representatives from Metrolinx, City of Toronto officials, and residential groups were present. Dante Mejia from OTG provided construction updates on King-Bathurst Station, discussing piling progress to date, upcoming work, accessibility at King-Bathurst upon opening, and strategies to reduce impacts on the neighbourhood.

After the Q&A session, Bradley reiterated Metrolinx' commitment to addressing local issues brought on by construction and shared Metrolinx community engagement contact information, email, and social media. Bradley concluded the presentation portion of the meeting by announcing the next King-Bathurst CLC meeting would be on June 6, 2024, to provide the latest updates.

QUESTIONS:

- **A resident asked about future TOC at the site, specifically related to piles and placement of the structure and footprint.**
 - **Metrolinx** and **OTG** responded that it is an Infrastructure Ontario project and neither Metrolinx nor OTG can speak to details surrounding future design at this time. More details will be shared in the future.

- **A representative from 1 Hotel Toronto raised some issues about property access with their valets and customer drop offs, in relation to the ongoing THESL work. The representative asked for an accurate schedule surrounding works, parking and restrictions, to better understand the coming work.**
 - **Metrolinx** committed to reaching out to the representative to confirm works schedules, brought on by Toronto Hydro.
 - **Metrolinx** and **OTG** also responded that no further lane closures were scheduled for King Bathurst soon.
