

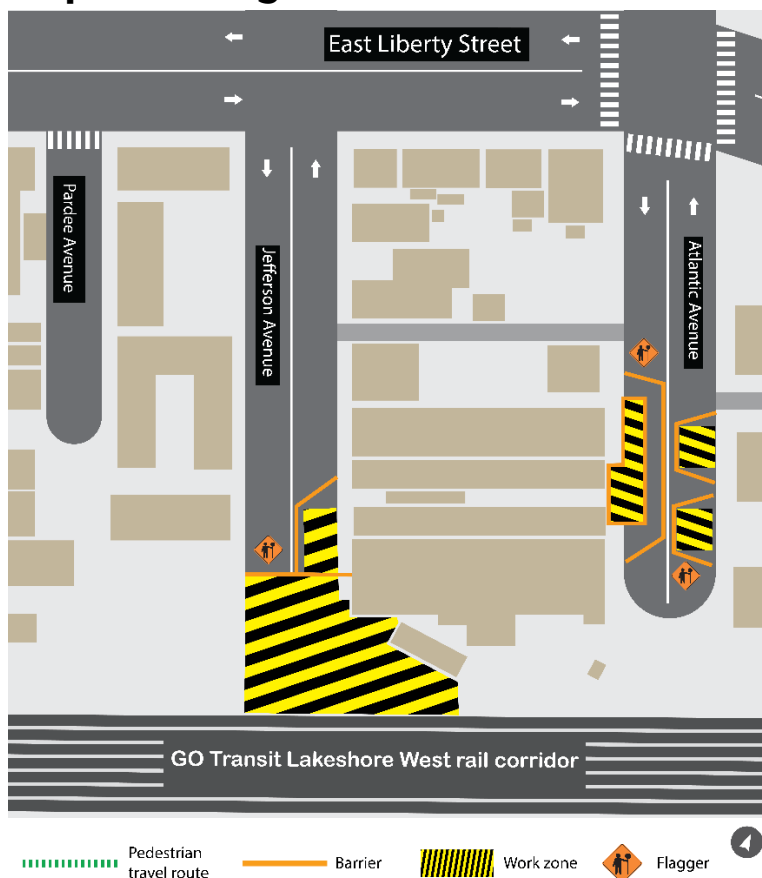
Monitoring device installation at Atlantic Avenue & Jefferson Avenue

Expected start date: As early as June 24, 2024

Expected duration: Through June 30, 2024.

Hours of work: 9:00 p.m. to 5:00 a.m.

Maps of roving work areas:



Monitoring device installations will move around the intersection, in the identified yellow work zones, one at a time.

Installations will not occur simultaneously. Crews will occupy a lane and/or sidewalk and complete the device installation before removing equipment and moving to the next location.

What is happening?

To prepare for construction of the Ontario Line Subway at the future Exhibition Station, crews will be installing monitoring devices at multiple locations near the south end of Atlantic Avenue and Jefferson Avenue.

- Roving, temporary single-lane closures are required for crews to safely carry out their work. Intermittent closures of the traffic lanes around active work zones are to be expected.

- No two work zones will be occupied simultaneously. Crews will move from one location to the next, once the device installation is complete.
- This work is done by accessing sewer manholes to assess the conditions of sewers and cabling before station construction begins.
- Crews will also drill into the road to install monitors. Once complete, the drill areas will be resotred. Equipment such as a saw cutter and hydrovac truck will be used.

What to expect

- Temporary, roving lane reductions for vehicles on Atlantic Avenue, as well as Jefferson Avenue.
- The work is scheduled to begin as early as June 24, 2024, and anticipated to be completed by June 30, 2024. Work will take place from 9:00 p.m. to 5:00 a.m., to limit impacts on traffic.
- Area residents and businesses can expect to hear noise from work equipment, specifically hydrovac trucks and saw cutting tools as required. Crews will take measures to minimize noise impacts wherever possible.
- All closures for work are temporary and intermittent; areas will only be closed while crews are surveying the specific areas. The areas will be returned to public use upon completion of the monitoring device installation.
- Work may be postponed or rescheduled due to unforeseen circumstances.
- All necessary construction permits have been obtained.
