

# East/West Traffic and Turning Restrictions for Track Installation at Mineola Road and Hurontario Street

Beginning Thursday July 25, 2024 at 10 p.m. to Wednesday August 28, 2024, at 10 p.m.



## Project Overview

The Hazel McCallion Line project will be an 18-kilometre, 19-stop light rail service connecting people from the Port Credit GO station to the Brampton Gateway Terminal.

## What You Need to Know

Crews will be welding tracks and doing concrete work for guideway installation within the intersection of Hurontario Street and Mineola Road. This work is scheduled to begin **Thursday July 25, 2024, at 10pm, until Wednesday August 28, 2024, at 10pm**. During this work, east-west traffic will be prohibited at Mineola Road, across Hurontario Street in each direction. Left turns will also not be permitted in the intersection. Detours for eastbound traffic along Mineola Road are available via Woodland Avenue, Inglewood Drive, Oriole Avenue, and Eaglewood Boulevard at the new signalized intersection to cross Hurontario Street. Detours for westbound traffic along Mineola Road are available via Broadmoor Avenue, Windy Oaks, Crossfield Bend, and Eaglewood Boulevard at the new signalized intersection to cross Hurontario Street.

In order to expedite construction ahead of the start of the school year, works at this intersection is scheduled to take place primarily from 7 a.m. - 10 p.m., seven days per week. However, as a contingency, crews have been approved to work overnight if required to finish ahead of Labour Day. There will be overnight paving on July 23-24 to prepare the intersection. Additionally, there will be overnight work on July 25 so crews can safely set up the staging area. Access for emergency vehicles across Hurontario Street along Mineola Road will not be maintained. Traffic signal timings will be adjusted to keep people moving. Pedestrian crossings will be maintained at a signalized crosswalk. Please follow the signs installed to assist with navigating around the closure. Transit services will be impacted by these construction works, including a detour for Miway Route 8. In accordance with City of Mississauga Noise By-Law Exemption requirements, this notice is meant to advise that residents near the work site can expect to hear noise and vibration caused by trucks, excavators, loaders, triaxles, backhoes, and other construction equipment related to this work.

Please note, work may be rescheduled due to weather or unforeseen circumstances. Please see roadway signage for the latest information. ### TIMING

- Intersection work is scheduled to begin July 25, 2024, and continue until August 28, 2024.
- Construction is primarily scheduled to take place from 7 a.m. – 10 p.m., Monday through Sunday.
- Work could be rescheduled and delayed due to weather conditions or unforeseen circumstances.

### TRAFFIC DETAILS

- Eastbound and westbound movements will not be permitted in each direction.
- Left turns at Mineola Road and Hurontario Street will not be permitted.
- Traffic delays are expected.
- Watch for slow moving vehicles entering and exiting work areas.
- Remember to reduce your speed when approaching lane reductions.

### WHAT TO EXPECT?

- Every effort will be made to minimize disruptions.
- Residents and businesses near the work site can expect to hear noise and vibration caused by trucks, excavators, loaders, tri-axles, backhoes, and other construction equipment related to this work.

### TRANSIT DETAILS

- MiWay Route 8 will be detoured.
- Visit [MiWay.ca](http://MiWay.ca) for updates on your bus route.
- Watch for additional signs directing passengers at bus stops as boarding areas may be relocated.

### PEDESTRIAN DETAILS

- Please take care when travelling near construction areas.
- Sidewalk access in the area could be affected.
- Watch for additional signs directing pedestrians as detours may be required.
- Clear and defined walking paths will be maintained during construction to ensure pedestrian safety.


### PROPERTY DETAILS

- Crews will not require property access for this work.
