
Construction Notice

East/West Traffic and Turning Restrictions for Track Installation at Mineola Road and Hurontario Street

UPDATE: Continuous Construction Works from 10pm on August 12 to 10pm on August 23



Project Overview

The Hazel McCallion Line project will be an 18-kilometre, 19-stop light rail service connecting people from the Port Credit GO station to the Brampton Gateway Terminal.

What You Need to Know

Crews will be welding tracks and doing concrete work for guideway installation within the intersection of Hurontario Street and Mineola Road. This work is scheduled to begin **July 25, 2024, at 10pm, and last until August 28, 2024, at 10pm**. During this work, east-west traffic will be prohibited at Mineola Road, across Hurontario Street in each direction. However, construction is expected to

take place primarily from 7am - 10pm, seven days per week. Left turns will also not be permitted in the intersection.

Detours for eastbound traffic along Mineola Road are available via Woodland Avenue, Inglewood Drive, Oriole

Avenue, and Eaglewood Boulevard at the new signalized intersection to cross Hurontario Street. Detours for westbound traffic along Mineola Road are available via Broadmoor Avenue, Windy Oaks, Crossfield Bend, and Eaglewood Boulevard at the new signalized intersection to cross Hurontario Street.

UPDATE: Continuous construction works are scheduled for 10pm on August 12 to 10pm on August 23.

In order to expedite construction and re-open the Mineola intersection ahead of Labour Day, crews have been approved to work continuously. Construction is expected to take place 24 hours, 7 days a week until August 23rd.

Access for emergency vehicles across Hurontario Street along Mineola Road will not be maintained. Traffic signal timings will be adjusted to keep people moving. Pedestrian crossings will be maintained at a signalized crosswalk. Please follow the signs installed to assist with navigating around the closure. Transit services will be impacted by these construction works, including a detour for MiWay Route 8. Please visit **www.miway.ca/updates** for updates on your bus route.

In accordance with City of Mississauga Noise By-Law Exemption requirements, this notice is meant to advise that residents near the work site can expect to hear noise and vibration caused by trucks, excavators, loaders, triaxles, backhoes, and other construction equipment related to this work.

Please note, work may be rescheduled due to weather or unforeseen circumstances. Please see roadway signage for the latest information. If you require the most up-to-date information, please reach out to **peel@metrolinx.com** and our team will provide you with e-updates of this work.

TIMING

- Intersection work is scheduled to begin July 25, 2024, and continue until August 28, 2024.
- Construction is primarily scheduled to take place from 7 a.m. 10 p.m., Monday through Sunday.
- Work could be rescheduled and delayed due to weather conditions or unforeseen circumstances.

TRAFFIC DETAILS

- Eastbound and westbound movements will not be permitted in each direction.
- Left turns at Mineola Road and Hurontario Street will not be permitted.
- Traffic delays are expected.
- Watch for slow moving vehicles entering and exiting work areas.
- Remember to reduce your speed when approaching lane reductions.

WHAT TO EXPECT?

- Every effort will be made to minimize disruptions.
- Residents and businesses near the work site can expect to hear noise and vibration caused by trucks, excavators, loaders, triaxles, backhoes, and other construction equipment related to this work.

TRANSIT DETAILS

- MiWay Route 8 will be detoured.
- Visit MiWay.ca for updates on your bus route.
- Watch for additional signs directing passengers at bus stops as boarding areas may be relocated.

PEDESTRIAN DETAILS

- Please take care when travelling near construction areas.
- Sidewalk access in the area could be affected.
- Watch for additional signs directing pedestrians as detours may be required.
- Clear and defined walking paths will be maintained during construction to ensure pedestrian safety.

PROPERTY DETAILS

• Crews will not require property access for this work.
