






Logan and Dundas bridges

Safety Moment - Road and Sidewalk closures

Full road closures are necessary to ensure safety while completing critical bridge work:

- Closures are communicated in advance via notices, email, social media, and signage.
- Map apps (Google Maps, Apple Maps) and GPS devices may not show the closure.
- Always follow signage and traffic personnel even if the road is shown as open on apps.
- Follow designated detour route and if possible, stay on major streets instead of side streets.
- Pay attention to which streets are one-way and always drive in the right direction.
- Avoid any distractions while driving at all times pull over and park safely if needed.



Bridge reconstruction: Queen St. E., Dundas St. E., and Logan Ave.

Bridge Reconstruction


- Work is ongoing to rebuild the Queen, Dundas, and Logan rail bridges
- Construction activities include concrete pours, formwork, and rebar installation

Timelines:

- **Queen bridge:** Work on the south side is completed, work on the north side of the bridge will start in late February 2025
- **Dundas bridge:** Ongoing on the east until early February 2025
- Logan bridge: Ongoing on the south until early February 2025

Hours of work:

- Monday Friday, between 7 a.m. 7 p.m., and occasionally on Saturdays between 7 a.m. - 5 p.m. and Sundays from 9 a.m. - 5 p.m.
- Overnight work may be required to complete critical activities that cannot be completed during the day. Advance notice will be provided for overnight work. No overnight work is expected during the holidays.




New tracks installed on the Queen Street bridge

Logan Avenue: Weekend road closure

- Once the abutments are complete, the new bridge girders will be lifted into place and installed.
- Logan Avenue will be closed over two weekends to complete the girder installation.
- The road will be closed between Dundas St. E. and Gerrard St. E. - access for local residents will be maintained.

Hours of closure:

- **First weekend:** Starting on Friday, December 13 at 8 p.m. until Monday, December 16, 2024, at 6 a.m.
- **Second weekend:** Starting on Friday, January 17 at 8 p.m. until Monday, January 20, 2025, at 6 a.m.
- Work will take place on a 24-hour basis during the closure
- Mitigations measures will be in place to limit community disruption
- Dates are subject to change and pending City of Toronto permits and approvals



- Construction activities will include pile drilling, steel and rebar installations, and concrete works
- Drill rigs, concrete trucks, lifts, and other machinery will be used to complete this work


Timeline:

- Prep work: Ongoing until Friday, December 20, 2024
- **Pile drilling:** Starting as early as Monday, January 6, 2025

 Monday - Friday, between 7 a.m. - 7 p.m., with some weekend work on Saturdays between 7 a.m. - 5 p.m. and Sundays from 9 a.m. - 5 p.m.

Temporary Noise Barrier Installation




- A five metre tall noise barrier will be installed for the piling work at Queen bridge
- The barrier will be installed in front of the piling work area and drilling equipment
- Approx. 120 metres of noise barrier will be installed on either side of the bridge

- A three metre tall noise barrier will be installed along the boundary of the rail corridor from Eastern Ave. to Queen St. and Queen St. to Dundas St. E.
- Solid wood hoarding will also be installed around the Queen access roads




Temporary Noise Barrier Installation - Approximate Locations



EARLY WORKS AND EASTERN AVENUE BRIDGE WORK

• Early Works may include such things as: establishing the work zone, moving equipment, supplies, and other resources, geo-technical investigations, utility daylighting, and track work.

• Early works are an important component of any construction project. These activities set the groundwork for major construction and reduce the risk delays to the project.

• Ongoing curb-lane closures on Eastern Avenue are in effect until October 2026*, to create a safe working zone for crews and machinery.


• There will be a full road, cyclist, and sidewalk closure on Eastern Avenue from Lewis Street to Dibble Street, with Local Traffic Only on Eastern Avenue from Broadview Avenue to Lewis Street as well as from Logan Avenue to Dibble Street. This work is for the safe transporting of conduit from the southern tracks of the bridge to the northern tracks. This is a nighttime closure and the dates are from Dec 4-6.

•We have entered stage 2 as of November 11, 2024, and will now begin mobilizing to work on the northern tracks of the Eastern Avenue Bridge, scopes of which are the bridge demolition and re-build.

Action: The Contractor confirmed that construction crews did not park on Paisley and that trucks belong to rail safety personnel. The contractor will mention the reminder in briefings, and Metrolinx will notify personnels not to park there.
2.	BranchesGerrard-Carlaw bridgeNovember 18, 2024	 Complaint received from the Councillor's office about branches being left in a pile around the Gerrard-Carlaw bridge. Action: The Contractor confirmed the work and branch pile are not theirs. Another contractor performed this work.
3.	GraffitiGerrard-Carlaw and Galt Ave.November 18, 2024	 Complaints received about graffiti on the noise barrier between Gerrard and Galt. Action: Metrolinx and the Contractor cleaned the graffiti at Gerrard and Galt, but it was then retagged. Metrolinx is working on graffiti maintenance plan which will be shared at the January CLC. High security fence will be installed in this area to deter graffiti. Metrolinx called back the resident to share this information.

If an exceedance is detected, crews on site are alerted and stop work until adjustments are made to reduce the vibration.



Action: Toronto Hydro turned off the power due to the safety risk posed by the branch's proximity to the power line. The Contractor notified Toronto Hydro of the conflict, and Toronto Hydro came on-site to investigate and, in response, removed the tree from the power line. Toronto Hydro needed to disconnect power when working near live power lines to protect the workers and the general public. Metrolinx was not aware that Toronto Hydro was planning to disconnect the power.
16.	ParkingDe Grassi St./Queen St.December 2, 2024	 Complaint received about the blocked parking on De Grassi. Action: The traffic barrels blocking the parking spots were removed.
17.	NoiseDe Grassi St./Wardell St.December 2, 2024	 Complaint received at De Grassi complained about the backup beeping sounds in the morning Action: The Contractor investigated and confirmed all trucks are equipped with broadband backup alarms. The Contractor also reviewed the noise monitoring data and did not hear any beeping sounds.

Action: The contractor confirmed they were placing granular to prepare a platform for the mobilization of the drill rig (a platform for the drill rig to sit on). Noise and vibration experts reviewed the monitoring data and confirmed no exceedances were detected. The work was taking place during the day within the communicated work hours, and a notice had been issued for the work. Metrolinx called back the resident and shared this information.
20	 Noise and vibration Queen St./McGee St. December 4, 2024 	 Complaint received a noise and vibration complaint from the resident at Queen St. Action: The contractor confirmed track work was being completed and needed to be done at night (when trains are not running) because the work is on the live tracks. The work will finish by approx. Dec 20. There was no work taking place on the actual bridge itself. The Contractor checked the noise and vibration data and confirmed all levels were within acceptable limits. Mitigations have been provided to the resident. A community notice had been issued for the work. Metrolinx followed up with the resident and shared this information.

Noise and Vibration Monitoring Update - November 2024



- There are thirteen noise and vibration monitoring instruments located across the Lakeshore East Rail Corridor.
- Most noise exceedances were observed on the weekends.
- Two noise and vibration monitors were relocated to the north side of the rail corridor (across from Degrassi St. and Wardell St.).
- No vibration exceedances were detected in November 2024.
- There was one day when exceedances coincided with noise complaints about overnight work during the weekend track closure in November.
