TOP Cancellation

1. Prior to contacting RTC, verify and record [check (✓) each item of the "Written Record of Verification"] that this TOP is not required for protection.
2. Read the TOP number, track and limits from the TOP being cancelled.
3. State to RTC **"I am not protecting anyone in these limits"**.
4. Underscore the TOP number, track and limits as they are read back by the RTC.
5. When requested to confirm against the written record, verify the checklist has been completed as indicated above and state to the RTC: **"I have confirmed, ok to cancel"**.
