OVERVIEW:

On Tuesday, May 13, Metrolinx hosted a virtual Queen Station CLC meeting in partnership with Ontario Transit Group (OTG).

After a land acknowledgment and a safety moment on site lighting, Metrolinx and OTG provided construction updates on completed work, current and upcoming work at the future Ontario Line station at Queen.

At the end of the session Metrolinx shared contact information and CLC members were encouraged to ask questions, which are outlined below.

QUESTIONS:

- **A member** asked about the vibration monitoring protocol.
 - **OTG** informed that monitors were in place to look after exceedances, but nothing has been reported.

- **The member** asked if this was a public document and if it could be shared with attendees.
 - **Metrolinx** replied that was not a public document, but a part of the contract.
- **Downtown Yonge BIA** asked if the monitoring data could be shared.
 - **Metrolinx** informed that an environmental assessment report is available [online](#).
- **Avison Young** asked if the exceedances are being shared if recorded.
 - **OTG** said that exceedances have not been reported for now.
 - **Metrolinx** noted more consideration would be required to answer the request related to the monitoring data report.
- **A resident**, living in an old building between Queen St E and Shuter St, expressed some concern about vibration and would like to talk with someone.
 - **Metrolinx** indicated that the building is out of zone of influence.
- **A member** expressed that their building is very fragile, and they want to have access to any reports related to their building.
 - **Metrolinx** will set up a meeting with the building directly.
