



Long Branch GO: Weekend and Overnight Work

November 29 - December 02, 2024

What Is Happening

Starting November 29, crews will be installing temporary rail bridges on top of the current tracks to maintain service while Long Branch GO Station is under construction. This work will occur on the weekends and overnight when trains are not running. The station will be closed over the weekend (exact timings overleaf). On-going platform substructure and utility work within the rail corridor will continue overnight.

Project Overview

Metrolinx's GO Expansion program is delivering more GO service across the network, including trains every 15- minutes or better on the Lakeshore West Rail Corridor. To support GO Expansion, we are upgrading the rail network and our GO stations to enable more frequent and fully accessible service. This includes accessibility and amenity improvements to Toronto's Long Branch GO Station located at 20 Brow Drive in Etobicoke.

WHAT TO EXPECT

- Residents should expect some noise, vibration, dust, and site lighting. Our staff will take reasonable precautions to minimize disturbances to residents and commuters, including but not limited to the following:
- Reduced idling of non-essential equipment
- Pointing lights away from residential windows
- The work area will be safely delineated.

HOURS OF WORK

- The work will begin in the evening of Friday, November 29th, 2024, and continue into the early morning of Monday, December 2, 2024.
- East platform works are on-going until August 2025 and will be overnight.

LOCATION OF WORK

 Work will be taking place on the East side of the station within our laydown and the rail corridor.

PEDESTRIAN DETAILS

- Pedestrians will not be able to access Long Branch GO.
- The temporary pathway from Edgeware Drive will remain open, however, access to north platform from the temporary pathway will be closed.
- Please exercise caution around active construction sites.
