

# Tree removals at Cosburn Station site and nearby area

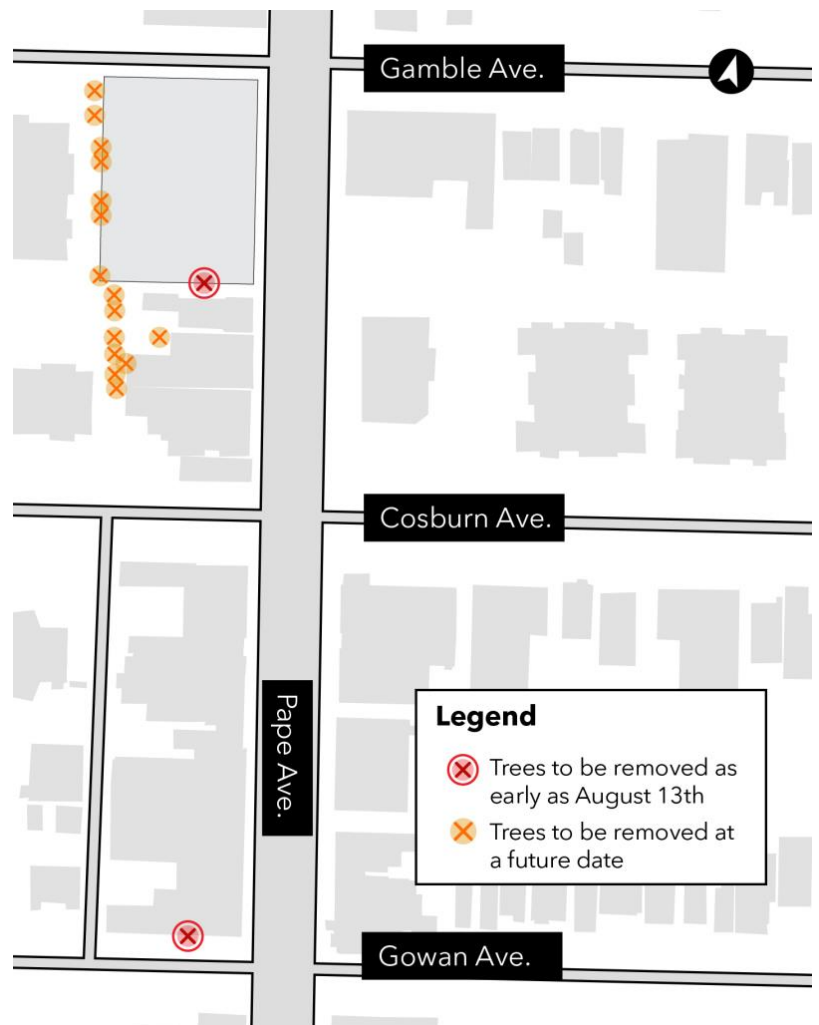
**Expected start date:** As early as August 13, 2025

**Expected duration:** One day

**Hours of work:** 7 a.m. to 7 p.m.

## What is happening?

- The northwest corner of Pape Avenue and Cosburn Avenue is the future site of Cosburn Station, a new subway station for the Ontario Line.
- To accommodate the future construction activities, crews will remove select trees and clear vegetation at the Cosburn Station site.
- Species at Risk (SAR) surveys during bird nesting season will be conducted to identify active nests or habitats of species at risk in accordance with the *Species at Risk Act*.
- Our vegetation guideline requires planting 1 to 50 trees for every one removed, depending on the tree's size and location. Typically, three trees are planted for every one that is removed. This ensures more trees are planted than removed as we carry out the largest transit expansion in the history of the region.
- Metrolinx is working closely with the City of Toronto and Toronto and Region Conservation Authority on replanting trees in the area, where possible. Learn more at [metrolinx.com/vegetation](https://www.metrolinx.com/vegetation).



## What to expect

- Two trees will be removed from the Cosburn Station site, with an additional 15 tree removals to be scheduled.
- Tree removal work is anticipated to take approximately one day.
- Work will take place on a weekday from 7 a.m. to 7 p.m.
- Noise from construction equipment including excavators, trucks, chainsaws and woodchippers can be expected.
- Construction equipment and materials will be properly secured within the work zone.
- This work may be delayed due to inclement weather and/or unforeseen circumstances.

## About the project

- 15.6-kilometre subway line that will make it faster and easier to travel within Toronto and beyond.
- 15 stops and more than 40 connections to other transit, including GO train, subway, LRT, streetcar, and bus lines.
- Less than 30 minutes from one end of the line to the other.
- 28,000 fewer cars on the road each day.
